



Results of the votes cast at the Annual General Meeting of Shareholders held on 2 April 2026

At the opening of the meeting 344,893,598 out of 345,458,994 Class A shares and 173,752,592 out of the 173,752,592 Class B shares were present or represented at the meeting, representing 96,93% of the Company's share capital.

The 2,053,690 FDRs held by the Company, the 23,952,416 FDRs held by SES Astra, and the 11,976,208 Class B shares held by SES Astra, are not included.

In accordance with article 450-3 of the law of 10 August 1915, as amended, abstentions are not considered when determining whether a resolution has been passed or not
